UCI Mountain Bike World Series Competition - Terms and Conditions

WIN TWO WEEKEND TICKETS WITH GONDOLA ACCESS TO THE UCI MOUNTAIN BIKE WORLD SERIES DOWNHILL WORLD CUP AT FORT WILLIAM, ON THE 03-05 MAY 2024.

FROM 26 MARCH 10AM GMT TO 2 APRIL.

- 1. By entering this MTBWS_FORTWILLIAM Contest, the entrant will be deemed to have read and understood these terms and conditions and to have agreed to be bound by them. The Promoter (details of which are set out in paragraph 19) reserves the right to refuse entry, or refuse to award the Prize, to anyone in breach of these terms and conditions.*
- 2. The Competition is open to all the MTBWS_FORTWILLIAM or @tahneeseagrave Instagram followers over the age of 18 residing in UNITED KINGDOM.*
- 3. Entrants must ensure that their participation (including the acceptance of any prize awarded) is lawful in accordance with the laws of the country of which they are a citizen and/or resides.
